FACILITIES

Bon Air Community Association offers 2 pools which are open from Memorial Day weekend to Labor Day, 9 Tennis courts of which 3 have lights and are open all year, a clubhouse available for rent to members at reduced rates, and during the Summer months a supervised recreation room with pool tables, ping-pong, etc. for children 8-16 plus a snack bar which offers lunches as well as snacks.
